Heads of the Non-Teaching departments, followed by another session for the Professors and Associate Professor of the varsity in the second half of the day.



Routine Surveillance Audit of NED University was conducted by the LRQA on November 30 to December 1, 2022. During this audit Dean (ISH) Office, Department of Urban & Infrastructure Engineering, Department of Electronic Engineering, Department of Food Engineering, Department of Metallurgical Engineering, Department of Physics, Department of Chemistry, Directorate of Finance, Directorate of Works & Services, Quality Management Cell and NED Academy were audited. One Minor NC was reported by the auditors; which was discussed in 38<sup>th</sup> BOR (University Level) meeting.

### INTERNAL QUALITY AUDIT

The 40<sup>th</sup> Internal Quality Audit was conducted on October 4-7, 2022. During the audit, observations of all the previous audits were also taken into consideration by the auditors and it was ensured that these observations were rectified.
