## Internal Quality Audit

The 42<sup>nd</sup> Internal Quality Audit took place from October 30 to November 2, 2023. Throughout the audit process, the auditors meticulously considered observations from previous audits, prioritizing the rectification of identified issues. The audit was executed in accordance with the approved Audit Plan and diligently carried out by internal quality auditors' teams. Subsequently, a comprehensive audit report was prepared and submitted to the Vice-Chancellor for approval. Upon receiving approval, the findings and observations outlined in the report were effectively communicated to all relevant departments, initiating the implementation of necessary Corrective and Risk Mitigation Actions. A total of twenty-two (22) observations were pointed out during this audit as follows:

- ◆ Scope for Improvement (SFI): 03
- ◆ Required Correction (RC): 14
- ◆ Minor Non-compliance (NC): 05
- ◆ Major Non-compliance (NC): 00

All observations have been rectified and the CMARs were closed.



## **Seminar on Ensuring Quality in Higher Education: A prospect of HEC Graduate Policy 2023**

The participants' feedback surveys of various training programs organized by the QMC/QEC have also been conducted and the corresponding statistical reports were prepared during the reporting period.

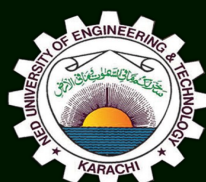
